

CCSTA Endowment Fund Tuition Assistance Program

The Vision of the Canadian Catholic School Trustees' Association states that we promote and protect the right to Catholic education in Canada. In keeping with this Vision, the Association has established an Endowment Fund (Charitable Foundation) to assist elementary and secondary students in their tuition costs at Canadian Catholic schools having limited or no government funding.

The principal, on behalf of students, submits the application to CCSTA. Applications should include one to two paragraphs per family, outlining the reasons for applying, special circumstances, personal involvement in school/parish activities, and faith commitment. To ensure confidentiality, refer to family as “family A”, “family B”, etc. All student information is to be kept on file at the school.

The principal will complete the Endowment Fund Tuition Assistance Program Application and the Student/Family Information Form(s), and forward it via email to the Canadian Catholic School Trustees' Association. Each school may request funding for a maximum of five families per school.

Applications will be received until March 30. The Endowment Fund Committee will reach its decisions regarding tuition support in May, and all schools will be notified by June 30. For those applicants receiving tuition funds, the money will be sent directly to the Catholic school in September, after receiving confirmation that students have returned to school. All funding is for one year; applicants may re-apply for funding in subsequent years.

If funds are allocated to a school with multiple student requests, and a particular student doesn't return in September, the school can re-allocate the funds to the remaining students.
